Message from the Director

Greetings!

Orange County Head Start (OCHS) takes great pride in presenting the 2020-2021 Annual Report. The Annual Report is a snapshot of the program's accomplishments, strengths, opportunities and barriers to meeting goals. OCHS has a long-standing history of being the premier early childhood education organization in Orange County in meeting the needs of children and families for over 50 years. Orange County Head Start is the largest provider of early childhood development services, funding 1,536 preschool children from economically challenged families living in Orange County. I deliver this report in partnership with the Orange County Mayor, Jerry L. Demings, Orange County Board of County Commissioners, Executive Director Lonnie C. Bell, Jr., Policy Council and the numerous committed employees that show up daily to impact our community and change lives.

In 2020-2021 the program totally changed the service delivery in many aspects of the program. OCHS started the year with 100% of the funded enrollment returning face to face. The program temporarily suspended parents in the classroom and all volunteering was halted. As classrooms shut down due to COVID outbreaks, another change included shifting to virtual classrooms during the 10-day guarantine period. This approach allowed our students to have consistent learning and minimized time away from the classroom. Early childhood classrooms looked very different. The children and staff went to 100% masking. The teacher to child close proximity indicator that was so vital before in an early childhood classroom was no longer acceptable. Different methods for cleaning and sanitizing classrooms were introduced to the teaching teams. The program purchased automatic sanitizing machines to clean more toys at a faster pace. Items that were once shared among students in a classroom during the beginning of the year, were now being purchased for each individual student in the classroom. The program purchased higher quality technology such as laptops for all staff, smartboards, swivel machine, tablets, hotspots and other technology that allowed us to support early childhood learning in a virtual world. Eleven new Standard Operating Procedures were added to support health and safety in the classroom and centers. These procedures directly aligned with best practices in an early childhood facility as it relates to COVID-19. All children were

screened prior to entering the classrooms, sign-in and signout took place outside, volunteers and parents were no longer allowed in the classrooms. The program decreased classroom sizes when there was an opportunity and reconfigured classrooms to add partitions and other COVID-19 friendly practices, to keep down the spread of COVID-19.

Orange County Head Start takes pride in delivering high quality, comprehensive services in a developmentally appropriate supportive learning environment. To maintain high quality services, OCHS made needed adjustments to our service delivery. The ACF-IM-HS-21-01Fiscal Flexibilities from the Office of Head Start, allowed the program to adjust and still adhere to federal regulations. In FY 2021, Orange County Head Start continued program operations through a global pandemic. OCHS remained current with the guidance and best practices from The Office of Head Start, The Center for Disease Control (CDC), The Office of Early Learning and The Department of Children & Families, to ensure the safety of children and staff. Orange County Mayor, and Board of County Commissioners provided added support to ensure day to day operations continued. Although we faced different challenges OCHS rose to the occasion.



Explanation of budgetary expenditures and proposed budget for FY 2020-2021

The proposed budget for **FY 20-21** was **\$23,910,101**. Funds received were used to provide fullyear, full-day comprehensive early childhood development services for **1,536** children and support to their families. Total expenditures of federal and non-federal funds for **FY 20-21** were **\$16,298,064**. All federal funds were used to cover salaries, cost of living increases, operation of services and training. The non-federal match (in-kind) was used to assist with salaries and operational expenses.

Efforts to Prepare Children for Kindergarten

Orange County Head Start (OCHS) utilizes the High-Scope Curriculum which promotes research-based teaching practices to support children's development and learning in all Head Start Early Learning Outcomes Framework (ELOF) domains. The program uses the Galileo Pre-K assessment tool, G3 Assessment Scales, to evaluate children's developmental progress. Teachers complete baseline assessments for each child and regular, ongoing observation and documentation of progress using the structured assessments provided.

OCHS has experienced a consistent increase in the number of children and families experiencing trauma and mental health concerns. Historically, OCHS has seen an increase in the number of children with diagnosed disabilities and mental health concerns. In preparation to provide additional focus on the social/emotional and mental health wellness of our children and staff, items were purchased for the classrooms, including books, sensory manipulatives, weighted plush animals, emotional expression and identification materials and items to create calming areas in the classroom.

Teaching staff who have and exhibit positive mental wellness are better able to meet the social/ emotional needs of their children. Training was provided for the staff including 6 steps to conflict resolution, acknowledging feelings, Positive Behavior and Intervention Supports (PBIS), Language & Literacy Fostering Communication, and Coaching using CLASS Lens. The topics for the 2020-2021 school year curriculum were focused heavily on the social/emotional, staff wellness compassion and mental health wellness of the classroom, including understanding the emotional & logical brain development of the children.

Parents also received training to enhance their social/emotional knowledge and addressing challenging behaviors at parent committee meetings. A parent training conference was held to assist parents in addressing the special needs of their children. Topics included Emotional Coaching, Adverse Childhood Experiences (ACES) and Understanding Child Growth and Development.

Due to the COVID-19 pandemic additional measures were taken to ensure the mental health of the children, families and staff. Our mental health services have been provided through a variety of Virtual Platforms. Therapist have reported that the majority of therapy time is used for parent education skills development and focusing on the parent's mental health.

All teaching staff was enrolled in the 7-day virtual "Transforming Challenging Behavior" conference which included topics relating to behavior, mental health and social/emotional regulation. To further address the mental health needs of the staff sessions were held with staff to complete the Professional Quality of Life Scale (Compassion Satisfaction and Compassion Fatigue Version). Staff was encouraged to reflect on their responses and provide encouragement and ideas to each other on how to avoid Compassion Fatigue.

The transition to distance learning had an impact on the achievement of Predicted DL scores, however Child Assessment data reflected in the chart below shows that all children did make significant gains in all domains. Overall, the data outcomes show that the curriculum and strategies implemented by Orange County Head Start are effectively working to ensure that children are well prepared academically, socially and emotionally to transition to Kindergarten. At the end of the 2020-2021 school year, a total of 579 children successfully transitioned to kindergarten.

Most of OCHS parenting programs requires families to participate face to face, and despite offering a virtual platform, the levels of participation were minimal to none. It was then decided to suspend all parenting programs, until next year.

Our goal is to better strategize the implementation of programs, with recruitment, optional virtual platforms and minor in person sessions; if applicable. Despite our circumstances, we will continue to engage and offer the programs for the upcoming year.
