

ORANGE COUNTY PRETRIAL DIVERSION DUI PROGRAM INFORMATION – OUT-OF-STATE

- Contract signing instructions: The contract will be mailed to you along with a CD presentation of the PTD/DUI information material. There are 4 pages that require a notary signature along with your signature; 1) the last page of the contract, 2) the joint stipulation, 3) the affirmation that you have viewed the CD presentation, and 4) the pledge, which includes your thumbprint. All originals must be mailed (not emailed or faxed) to the officer as directed. You are required to submit a fingerprint record as instructed. (Can be obtained at a local law enforcement agency.)
- Prior to or upon receipt of the contract, you should locate a Victim Awareness/ Impact Class through **MADD** in your state of residence.
- Prior to or upon receipt of the contract, you should locate a DUI Level I class in your state of residence. The DUI Level I class must be equivalent to the course offered by the Florida Safety Council (1-800-372-3335). A substance abuse evaluation must be included, either through the DUI school or an independent licensed provider. Any counseling recommended by the evaluation must be completed in person (not online).
- You must comply with all reporting requirements as directed by the DUI Pretrial Diversion Officer, whether electronic, telephone, mail or other means of communication.
- <u>Non-compliance:</u> If conditions are not completed according to the PTD contract and supervision plan, you may be required to report **in person** to Orange County Community Corrections Pretrial Diversion, 3723 Vision Blvd., Orlando, FL 32839 upon notification from your officer.

DUI Diversion (Tier I)- BAC <.150

- Program length: 9 12 months
- Telephone Reporting \$55 (for 9 months, \$73 for 12 months)
- Monetary Contribution to MADD (Central Fl. Chapter only) or Victim Service Center of Orange County - \$500
- Community Service: 50 hours (minimum)
- Prosecution Fee: \$50 payable to Orange Co. Clerk of Court (per court case number)
- Cost of Supervision: \$600
- Ten-day vehicle impoundment/immobilization

DUI Diversion (Tier II)-BAC .150> & refusals

- Program length: 12 15 months
- Telephone Reporting \$73 (for 12 months, \$91 for 15 months)
- Monetary Contribution to MADD (Central Fl. Chapter only) or Victim Service Center of Orange County - \$1000
- Community Service: 50 hours (minimum)
- Prosecution Fee: \$50 payable to Orange Co. Clerk of Court (per court case number)
- Cost of Supervision: \$750
- 6 months ignition interlock This is mandatory for Tier II Diversion. If you cannot complete this requirement, you need to discuss it with your officer prior to committing to the program. (Note: some interlock programs cannot accommodate hybrid vehicles.)
