- A site plan depicting the boat ramp facility and any other existing or proposed improvements (including parking spaces) at the boat ramp facility site. The site plan shall depict the Normal High Water Elevation (NHWE). The site plan shall include the design requirements as outlined in Chapter 15, Article XV, Section 15-605. A site plan for a semi-private boat ramp facility or commercial boat ramp facility must be prepared by a professional engineer registered in the State of Florida.
- Calculations regarding the amount of fill and excavation that will be required for construction of the boat ramp facility.
- A list of materials that will be used to construct the boat ramp facility.
- Cross section survey depicting slopes, elevations and depth profiles of the boat ramp facility.
- Agent Authorization Form
- Relationship Disclosure Form
- Specific Expenditure Report Form
