



**Application – Timber Harvesting (Exempt Agricultural Property)**

This Application shall be used for timber harvesting or tree removal activity on property used for bona fide agricultural purposes *and classified as such for property-tax purposes by the Orange County Property Appraiser.*

A Zoning review fee in the amount of \$153.00 (Land Use Permit Application fee of \$32.00 and a Timber Harvest Permit Application fee of \$121.00) is due at the time of Application. Make checks payable to the ‘Board of County Commissioners’ or complete a Credit Card Authorization form. Be aware that if other departmental reviews are necessary, additional review fees will apply and will be due upon permit issuance.

The Orange County Business Tax Office requires payment of fees. Contact the Business Tax Office at 407-836-5650 for questions.

Zoning approval of this Application does not authorize removal of existing ground cover nor does it authorize ground clearing or use of heavy earth-moving equipment. Contact Orange County Development Engineering at (407) 836-7974 if such activity is proposed.

Zoning approval of this Application does not authorize removals in wetlands, conservation areas or in wildlife areas. Contact Orange County Environmental Protection at (407) 836-1400 if such activity is proposed.

Attach a tax map or an Orange County Property Appraiser’s aerial illustrating the proposed harvesting area to this application.

A survey (or surveyors certification that no protected trees per Chapter 15-301 exist) of the harvest area is required if the Comprehensive Policy Plan’s Future Land Use Map designation is not Rural for the parcel(s) listed.

A Zoning Division Arborist will review the application for the zoning, Property Appraisers’ Tax Classification and the CPP land use designation of each of the parcels listed on this Application. Additional reviews will be required by the Orange County Environmental Protection Division and Orange County Development Engineering. Allow up to 14 days for a complete permit review.

The approved permit will be valid for 60 days from date of issuance.
