Greater Flexibility and Access to Quality Primary Care — For the 2017 legislative session, Florida Sen. Tom Lee filed a bill (SB 240), designed to improve access to direct primary care. The proposed bill would allow patients to pay a flat monthly fee as opposed to the traditional third



party, fee-for-service system. According to Sen. Lee, "This type of free -market approach grants patients greater flexibility and expands access to concierge-level healthcare that was once available only to the wealthy." Read article at www.flsenate.gov.
