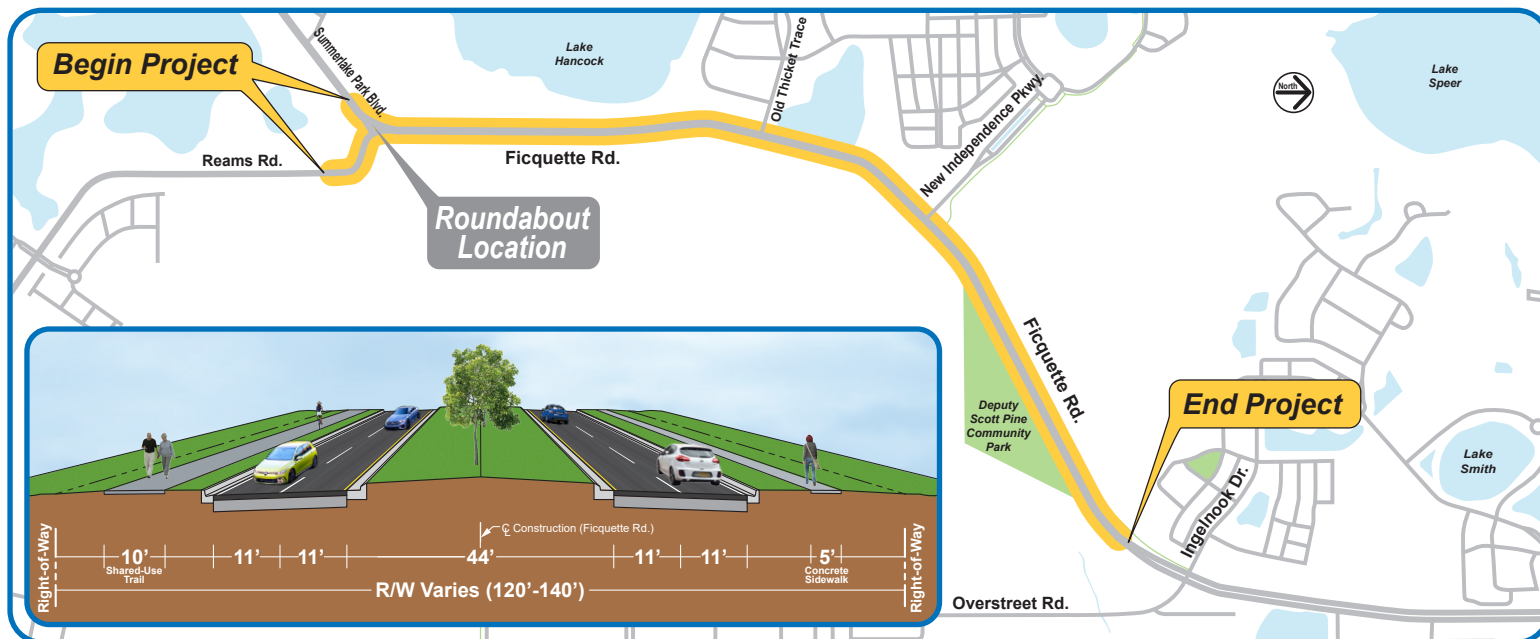

Construction Beginning First Quarter of 2026

The design, permitting and right-of-way acquisition phases are being completed. Construction is anticipated to begin in the first quarter of 2026 with a construction time of approximately two years.

Project Summary

The Orange County Public Works Department plans to widen approximately 2.0 miles of Ficquette Road from south of the Reams Road/Summerlake Park Boulevard intersection to south of the Ingelnook Drive intersection from two to four lanes. The proposed design includes two, 11-foot-wide travel lanes in each direction

separated by a raised, grassed median. A shared-use trail will be provided on the west side and a five-foot concrete sidewalk will be provided along the east side.

The project will include realigning the existing S-curve at the Ficquette Road/Reams Road/Summerlake Park Boulevard intersection along with the addition of a roundabout at that location. Intersection improvements will also be provided at Old Thicket Trace, New Independence Parkway and the Deputy Scott Pine Community Park entrance. New stormwater retention ponds will be constructed. Lighting and landscaping will be provided along the roadway corridor.
