 - Online at www.MyOrangeClerk.com. Case or citation # is required.
 - Mail: Check or money order *only* (payable to **Orange County Clerk of Courts**)

- **Unable to pay ticket by due date?**
 - Request an extension online at www.MyOrangeClerk.com.
 - \$4 fee for 30-day extension (*2 max extensions*)
- **Submit an Affidavit**
 - For denying responsibility or accepting responsibility.
 - Download & print an affidavit at www.ViolationInfo.com.
 - Affidavits must be received by Clerk's Office on or before due date.
- **Request a hearing**
 - Indicate your request, sign and mail the original citation to the Orange County Clerk of Courts.
- **Failure to respond by the due date results in a suspended license & additional fees.**
