Ms. James introduced the changes discussed between the last meeting and this meeting, and has provided a list of changes needed to the draft submitted last week.

The Committee commenced their review of the redline version of Horizon West–Town Center Horizon Vue PD Road Network Agreement Page-by-Page:

Page 3

- Change acreage in Recital M from "3.31" to "3.28"
- Line 92 change "16.87" to "16.72 for "net developable acreage"
- Line 94 change "2.08" to "2.23"
- Line 95 change "1.23" to "1.05"
- Line 110 change "November 11, 2020" to "November 2020"
- Line 111 change "January 4, 2021" to "January 6, 2021"

Page 4 no changes

Page 5

- Section 6.2 acreage from "0.85" to "1.00"
- Ms. J. Cummings stated she calculated different drainage numbers, and informed Ms. James that she needs to pull out certain areas which are not included in the overall values. Per Ms. James's email values are to change in the last paragraph. Total acreage should be 10.95 acres.
- Ms. J. Cummings to provide updated changes to the agreement language per what she displayed on the screen. The contributing area is not to be included in the total pond area.

- Section 7 line 177 change "2.08" to "2.23" and "1.23" to "1.05"
- Section 8 line 180 change both instances of "1.23" to "1.05"
- Section 8 line 182 change "\$56,094.15" to "\$47,885.25"

- Section 9.2 line 220 add language as reflected in the changes emailed by Ms. James to further define the southern boundary of the SMA tract.
- Ms. Almodovar objected to the POA being established at a later date (must be established now). Mr. Trace stated that POA is not yet established but would welcome a trigger linked to apartment site. Ms. Almodovar to add as a Condition of Approval to the apartment site.

Page 8

- Lines 280-286 refers to a future amendment however page 9 provides for conveyance of right-of-way, need to rephrase to award credits upon conveyance of right-of-way.
 - o Credit for right-of-way was supposed to offset against future Fair-Share obligation.
 - o Credits to be awarded at time of conveyance and to be applied at a later date to Fair-Share Payment obligation.
 - o Ms. James to work with Ms. Alfonso to revise lines 273-286.

Pages 9-20 no changes

Page 21

Exhibit B not clear needs to be cleaned up for final review version

Pages 22-24 no changes

Page 25

- Lines 733-740 rights of Grantee need to be provided
- Self-Help provision does not give County the right to enter the property in case of an emergency. County must have right to do so.
 - o County will need to construct inlet pipes to access the pond so need ability to do so.

Ms. James stated this language is to protect owner against the County coming back and asking for a larger pond at a later time. County needs right to construct, install and connect to pond. Mr. Stehli spoke to pond being constructed with apartment site so pond will be in place prior to road construction. Timing of construction of the pond was discussed also. Ms. Alfonso to work with Ms. James to further revise this paragraph regarding Self-Help Provision and finalize Drainage Easement.

Mr. Weiss suggested adding a Condition of Approval to the Apartment DP requiring construction of the pond, but this will not be sufficient if apartment fails to move forward.

Responsibility of in-flow pipe from CR 545 to pond falls to County so need right to inspect, maintain, and construct.

Ms. J. Cummings suggested looking at Wildwood Agreement for Drainage Easement Language.

Discussion of Temporary Construction Easement being included within drainage easement.

Mr. Weiss discussed the proposed revisions to the agreement and instructed Ms. James to bring the agreement back to the next RAC meeting on February 3, 2021 for additional review, and asked Mr. Raasch to schedule it for a future BCC agenda (possibly March).

No Action taken by Committee.

Mr. Weiss adjourned the meeting at 12:06 p.m.
