Mr. Weiss asked whether the Waverly Walk Proportionate Share Agreement needs to specify language for using funds on an alternate roadway.

Committee decided to move Waverly Walk forward to use funds on University Boulevard as specified.

Mr. Williams made a motion, with a second by Ms. Almodovar to approve Caliber Car Wash Proportionate Share Agreement, Waverly Walk Proportionate Share Agreement, and Fifth Third Bank Proportionate Share Agreement with changes discussed. Motion carried unanimously.

COMMITTEE DISCCUSION: Fifth Amendment to Vineland Pointe PD

- Mr. Nastasi provided an overview of the status of the project including status of PDS and Design.
- FDOT Interchange at Daryl Carter Parkway requires right-of-way from Vineland Pointe PD, and was
 original source of retention for Vineland Pointe PD that did not work out and I-4 was the original
 destination for retention for Vineland Avenue
- \$4 million escrowed funds is proposed to increase to \$5 million
- County would release all holds on Certificates of Occupancy for Vineland Pointe
- Payments made under Protest may be refunded as credits are earned
- Mr. Weiss summarized that FDOT right-of-way is critical. The tradeoff is that the County will take on Vineland's responsibilities, and allow Vineland Pointe PD to build out.
- Mr. Lee stated the applicant is still willing to participate in working with property owners in the area to help obtain right-of-way as needed
- Mr. Williams has a concern with shifting responsibility to County to acquire right-of-way
- RAC Committee was generally supportive of the concepts as outlined
- Mr. Lee was instructed to add several Whereas Clauses to outline the history and context of agreement
- FDOT will advance project if right-of-way is in place by Spring 2020 for a construction start date of October 2021 for interchange. County would need to get a final Fifth Amendment to BCC by early March
- Mr. Lee to submit by January 27th for review at the February 5th RAC Meeting

Gem Groves PD APF Agreement

Road Affected: Avalon Road Present: Carolyn Haslam, Chris Roper, Dell Avery, Paul Rosenthal, Lance Bennett, and Teri Bowley Previous RAC: December 11, 2019 Others Present: Steven Thorp (OCPS)

Ms. Haslam provided an overview of the outstanding issues:

First Issue – School Access. Original SAP identified road to the school site. County does not want to maintain a school access road, and OCPS does not want to maintain the access road. Every school must have public access. Private roads are not permitted.

- Ms. Almodovar explained that Flemings Road is the access to the park, and any path from Flemings Road to the school parcel would be private.
- > Mr. Raasch stated the SAP shows this access as an APF Road.

Second Issue – Mr. Bennett raised the issue of the Flemings Road intersection which is somewhat offset and needs to be re-aligned as part of Village I Road Network Agreement since slightly shifted to the North.

> PDS review should look at the ultimate intersection.

Third Issue - Lake Star Road. Lake Star Road also connects to Flemings Road at the County Line.

- > Realignment to be accomplished through PTV process.
- ▶ 4.11 acres for APF right-of-way, and the remainder to be swapped in new alignment.
- Ms. Almodovar stated a realignment is needed for Lake Star Road within the Cantero Property.
- > Mr. Bennett stated APF acreages are still being adjusted.

Page 7

 Discussion of School Entrance – Cannot have students dropped-off on Flemings Road or C.R. 545 to walk into interior school site since it creates a dangerous condition.

Page 9

- Line 18 restore "13" after "ASTM E-1527"
- Discussion of Impact Fee Credit eligibility: Flemings Road and Avalon Road are the only roads eligible for impact fee credits. Lake Star Road and School Access Road are not eligible for impact fee credits. Must be clarified in the agreement.
- Add Recital stating County Engineer has declared Flemings Road road impact fee credit eligible.

• Line 32 after "such" add "impact fee eligible"

Page 11

- Line 1 add "(b)" after "Section 5"
- Line 25 remove "General or" in reference to type of deed

Page 13

• Specify "school" impact fee where it's appropriate

Page 14

- Line 22 add the word "Management" after "Estate"
- The 5% threshold being requested to be waived in PD. Discussion arose of who will be tracking the 5% and/or 42nd unit. No consensus. Will be discussed at a later time.

Page 15

 Last sentence (top of page) is in direct conflict with mutual determination previously noted. Potential solution is to cite back to Section 5(b).

Page 18

Subsection (ix.) OCPS remedies are different from OC. Mr. Roper to cross reference previous Village I agreements to remain consistent, and not to conflict.

Page 19

• Ms. Alfonso and Mr. Roper to confer on changes to subsection (xii)

 Mr. Thorp questioned names included in the OCPS signature page. Ms. Haslam to double check with Ms. Kelly from OCPS.

Mr. Sponenburg made a motion, with a second by Mr. Raasch, to approve the Gem Groves PD Adequate Public Facilities Agreement with the changes discussed, subject to Ms. Alfonso resolving the remedies language with the applicant, subject to final review of exhibits by County Survey, and subject to final review by the committee. Motion carried unanimously.
