The purpose of this notice is to make you aware of the updated fee schedule that affects all fire hydrant installations, relocations, and removals within Unincorporated Orange County.

With the approval of the 2024 Budget, the Orange County Board of Commissioners approved and adopted a new fee schedule that became effective October 1, 2024.

As of October 1, 2024, all fire hydrant installations, relocations and removals will be assessed a one-time permitting fee of \$35.00 (this payment and fee are for up to five hydrants). Fees will be accessed during the underground permitting process.

The Orange County Fire Rescue Department strives to provide the highest quality fire prevention and emergency services to protect our public health and safety, while reducing property loss. Your cooperation will ensure that the fire hydrants in Orange County are available and ready for use when the need arises.
