Orange County Outdoor Public Assembly, Special Event and Block Party Definitions


An **Outdoor Public Assembly Permit** is required by Orange County Ordinance for an event (except a funeral procession) that is:

- Held partially or entirely on public property, right-of-way, sidewalk, and/or roads, and
- Expected to be attended by 100 or more people
 - o In the case of public parks, it would be 700 or more people

A **Block Party Permit** is required by Orange County Ordinance for a neighborhood social event taking place either partially or entirely on a road in a residential area and which obstructs vehicular traffic.

A **Special Outdoor Event Permit** is required by the Florida Fire Prevention Code for outdoor events, interpreted as being not on public right-of-way, that are reasonably expected to be attended by 100 or more people.

It should be noted that depending on the makeup of the event, there are times where both an Outdoor Public Assembly and a Special Outdoor Event is required.

REMINDER:

- 1. All signatures must by notarized.
- 2. Include a \$100.00 payment confirmation.
- 3. Include a detailed site plan.
- 4. Application MUST be submitted a minimum of 35 days prior to event starting.
- 5. Insurance Certificate:
 - a. Certificate Holder should be: Orange County, Florida Risk Management 109 E. Church Street. Orlando, Fl. 32801
 - b. A minimum of 30 days is required for the cancellation period.
 - c. Certificate must state that Orange County is an Additional Insured.
 - d. The name and date(s) of the event must be stated on the certificate.


