The property owner hereby requests wastewater capacity in the amount of ERUs shown in Item 11 for the properties described in Items 13 and 14, and agrees to be bound fully by the provisions of the Orange County Code (OCC), Chapter 37 (Water & Wastewater), as it may be amended from time to time, and the terms and conditions of any wastewater reservation or permit issued pursuant to this application. The property owner hereby accepts all terms and conditions of an Orange County Wastewater Reservation or Permit which may be imposed if such reservation or permit is issued, up to and including a reduction of wastewater capacity as applied for hereunder pursuant to the Wastewater Allocation Rules, as amended from time to time, unless the property owner withdraws this application. To withdraw this application, the Property Owner must send written notice, executed in the same manner as this application, by United States Mail, postage prepaid, certified mail, return receipt requested or hand delivered, addressed to: Orange County Utilities, Attn: Development Team, 9150 Curry Ford Road, Orlando, FL 32825-7600.

This application for and any subsequent wastewater reservation or permit issuance by the County shall not create vested rights for the applicant and shall not be construed as a guarantee of wastewater service to the applicant or the real property herein described. The County may allow connections to the wastewater system only if, at the time such connection is to be made, it remains lawful to make such connections and would not thereby violate any permit, license, restriction, injunction, moratorium or denial of permission to connect, construct facilities or operate facilities imposed or issued by any court of competent jurisdiction or by any applicable Agency of the United States, the State of Florida, or the County. The County makes no other representation or agreement as to the availability of wastewater service in connection with the development of the property as described herein. The applicant expressly agrees that it shall have no claim or cause of action against the County for the County's observance of Chapter 37, OCC, as amended from time to time, or any such permit, license, restriction, injunction, moratorium or denial of permission to connect to its wastewater system, construct facilities, or operate facilities. Therefore, applicant hereby waives and relinquishes any right, claim, cause of action or other remedy whatsoever against the County arising from or as a result of the County's refusal to allow the applicant to connect to the County's wastewater system for in observance of Chapter 37, OCC, as amended from time to time, or any such permit, license, restriction, injunction, moratorium or denial of permission to connect to its wastewater system, construct facilities, or operate facilities. This application is submitted pursuant to the provisions of Chapter 37, OCC that are expressly incorporated herein.

As the current property owner and applicant, and on behalf of its successors and assigns, I/we agree to indemnify and hold the County harmless from any and all liability, loss, or damage, including reasonable costs and up to and including attorney's fees, which arise from or are in any way related to this application for wastewater capacity.
